

Roofbase TV prize Draw

Who can enter:

- This prize draw is open to UK residents that hold either a Roofbase credit account and or a Roofbase cash account. (a “Participant”) Participants must be aged 18 or over and cannot be employees of the Promoter (an Employee”), an Employee’s immediate family, their agents or anyone else professionally connected with these Prize Draws.
- These Prize Draws will run from 00.01 on 1st September 2024 until 11.59 on 29th November 2024 (the “Qualifying Period”)
- These Prize Draws consist of nine (9) Branch Prize Draws, (each a “Branch Prize Draw”, together the “Prize Draws”). A participant will be entered into the prize draw at the first branch they made the transaction. Question – do customers shop across branches?

How to enter:

- To enter the prize draw, a Participant must hold either a credit or cash account and make a transaction on either a credit or cash account during the Qualifying Period.
- The order must be placed at a Roofbase branch or over the phone with a member of staff at a Roofbase branch.
- In the event that a Participant makes a transaction at more than one branch during the Qualifying Period, they will be placed in the Branch Prize Draw for the first branch they placed an order at.
- Participants cannot be entered into more than one Branch Prize Draw, and there can only be one entry per Participant.
- Any Entry (and subsequent Prize (as defined below) is for the benefit of the Account holder.
